


HARDY SOCIETY MEMBER PROFILE

Mary Ann Hyde

After 100 years of an extraordinary life, Mary Ann Hyde passed away peacefully in December 2023. Mary Ann filled her life and the lives of her family and friends



with kindness, her signature sense of style, and her love of music. She was a gracious hostess and had many memorable dinners and parties, frequently featuring live music by AMFS students.

Throughout her life, Mary Ann gave generously of her time and resources to support the arts. Her many interests included the National Society of Arts and Letters, Washington's National Democratic Club, Bethesda Garden Club, Congressional Country Club, and other prominent Washington-area organizations. Her love of skiing brought the family to Aspen full time in 1969. She was a member of the Society of Fellows at The Aspen Institute, and she supported the Aspen Music Festival and School by serving on the Board of Trustees, as chair of the opening gala for Harris Concert Hall in 1993, and as a member of our National Council for the remainder of her life. She loved attending the Sunday afternoon concerts and enjoyed getting to know the musicians, including her favorites, Pinchas Zukerman, Bobbie McDuffie, and Sarah Chang.

Mary Ann took her legacy seriously, working on her estate plans for decades. She worked with an estate planning team to make sure her wishes were detailed and her intentions were well-documented. She believed that careful advanced planning was important for her family. Her gift to the AMFS was made in recognition of her love of music and to celebrate her life at a summer Festival concert. We are honored to be part of her legacy and to help her friends and family come together to celebrate Mary Ann during this 75th anniversary season.

Your will is personal

Planning a will is typically regarded as a responsibility, but it is also an opportunity to ensure that your personal goals are understood and ultimately achieved.

Plan with others in mind

Planning your will is well worth the time and thought you put into it. By choosing how your assets will be distributed, you determine the ways in which you will help and support others. Whether giving a specific asset to a loved one or providing future support for AMFS, creating a will that is unique to your circumstances and reflects your heartfelt wishes can provide great personal satisfaction.

Specificity is important. For example, you may have family heirlooms that you want to leave to particular family members, or you may have a dependent loved one you wish to provide for in a certain way. Your will can include the necessary instructions and provisions to reach these goals, along with many others. Your will can also help you meet your philanthropic goals without impacting your current finances or diminishing your commitment to loved ones.

Understand your will's importance

A will gives you the opportunity to:

- 1. Make key decisions. Your will is a vital legal document that directs your final affairs. You have the opportunity to choose an executor, make planning choices that may minimize taxes and ease estate administration, identify a guardian for minor children, and so on.
- 2. Provide for people and organizations you care about. Failing to create a will means your estate settlement and asset distribution will be governed solely by state law, with no consideration for the

- unique ways you want to provide for others. Without a will, the people and organizations you care about can be left with nothing.
- 3. Ensure peace of mind. Putting clear, thoughtful instructions in place will provide great peace of mind for you and your family members. Your loved ones will know that you have made careful decisions and provided clear instructions, relieving them of the burden of making those decisions at a difficult time and perhaps without full knowledge of your wishes.

Update to reflect life changes

Your will is flexible. You can adjust it throughout your lifetime to reflect changes in your family situation, needs, and goals. Amending your will doesn't have to be a difficult or complicated task. Consult with your attorney—it may not even be necessary to create a new will.

Will planning tips and tools

A will directs your final legal affairs and documents a plan for helping others through the thoughtful distribution of your assets. We gladly offer the following tools to help you consider your options, inventory your assets, and start creating your will.

Know your giving options

A gift in your will can be a key component of your personal legacy, shaping how you are remembered. It is a comfortable commitment—it doesn't impact your current finances, and you can change it in the future if your circumstances or goals change. It is also flexible. You can support transformational and inspirational musical experiences by designating a gift of:

- A specific amount or asset
- A specified percentage of your estate or of a select portion of your assets
- What is left in your estate after all other debts and obligations are met

When you choose to make a gift in your will, you can also direct how you want your gift to be used. Please let us know if you are considering such a gift—we want to be certain we understand your goals, and we can provide you with the legal language you'll use to clearly designate the gift. Inventory your assets

Once you determine how to distribute assets, you need to know what assets are available. Making an asset inventory sounds simple, but doing it well requires thoughtful diligence.

The reward for your careful attention is that you develop a big-picture view of what you have available to meet your specific goals. You may find that you can do more for others (including charitable organizations like the AMFS) than you originally thought. If your estate is uncomplicated, you might consider an online will-making tool. The Aspen Music Festival and School has recently started a partnership with Giving Docs, a digital estate planning platform that makes it easy to create a simple will. Anyone who is interested in this tool may create an account and have free lifetime access to online estate planning tools and other legal vehicles. You do not have to include the AMFS in your planning and you do not need to disclose your private information to us—it is simply our gift to you!
